Action Item(s)	Status
Update the Academic Misconduct portion of the Student Code of Rights, Responsibilities, and Conduct.	In 2012 a major revision of the procedures associated with academic misconduct was undertaken by the committee in collaboration with the Office of Student Conduct. Recognizing that revisions are needed, a sub-committee led by Robert Yost and members of the Community of Practice on Academic Integrity made significant progress on revising the procedures..
Campus Pedestrian Safety	A sub-committee was formed to investigate issues related to pedestrian safety on campus.
Older Students (Adult Learners)	A sub-committee was formed and initial data collected to answer the question, do older students feel comfortable on campus.
The committee heard a presentation from Jason Spratt regarding changes and updates for the Division of Student Affairs.	Of particular note was the hire of Dr. Eric Weldy, the growth of professional staff (notably counseling staff), the increase in student organizations, and number of residence beds on campus.
Brian Tomlinson, Assistant Dean and Director of Student Conduct Deputy Title IX Coordinator, gave a presentation on misconduct issues.	Mr. Tomlinson reviewed the responsibilities of office and plans to hire staff with particular expertise in conduct issues.
Update/report from Undergraduate Student Government	Representatives were particularly concerned that the introduction of the Crimson Card would erode the sense of identity undergraduates have with IUPUI.
Committee Response to RISE Scholarship	The committee provided feedback and gave approval for the RISE Scholarship.
